GUEST SPEAKER – One of our own – PHIL PENMAN

Introduction - Brian Logan

Self-Funded Retirees – where does one start? Everyone has an opinion and the Financial Adviser is often the last to be asked or listened too so opened Phil's talk today.

Everybody has different ideas about retirement and what is important to each person / couple has to be discussed and decided by the individual or couple rather than going to a financial planner with no ideas about the future at all. Retirement goals need to be set – essential needs – lifestyle wants and legacy aspirations need to be considered.

Consider investing across a range of asset classes –

- 1. Cash in the bank (limited interest earned term deposit or working account)
- 2. Fixed interest (government bonds, corporate bonds)
- 3. Equities (shares, dividends) including international shares
- 4. Property (commercial, residential)
- 5. Infrastructure (roads, airports etc).
- Compulsory super came in 1992 both sides of government favoured this concept as the way to go.
- > Funds invested in super is to provide monies on retirement to members in that particular fund.

Note – Members aged 55 / 60 and above should consider moving to pension phase to reduce the 15% tax on earnings that they incur in the accumulation phase.

Note – in pension phase, there is no capital gains tax, no tax on earnings and (for those over age 60) no tax on pension payments.

- Australian Share Market has one of the most consistent and highest, dividend payment levels in the world New Zealand ahead on 4.8 return Australia averages a 4.6 return
- > Returns on Term Deposits over any medium time frame has always underperformed other asset classes.
- ➤ On the current market if you are seeking double digit interest rates not going to happen. Must be realistic with expectations.
- ➤ If you are only considering term deposits and need \$58,000 / \$60,000 per annum to live on, you would need at least \$2M invested. Must consider a more diverse portfolio.
- International Shares post GFC have been the best performing asset class but Self-Managed Super Funds on average have less than 1% exposure to the class.
- > SMSF's have on average allocated over 30% of assets to cash which has been over time, the poorest performing asset class.

Everyone's situation is different and currently less than 20% of Australians engage a financial planner. Banks are making a big push in this area as they see a large opportunity going forward.

Legislation now prohibits people providing advice if they are not licensed so there will be an ongoing growth in the financial planning industry. Accountants also facing licensing requirements over SMSF advice so it is just a sign of the times and the importance to ensure advice is provided with the best interest of the client in mind.

Markets move up and down in the short term and that volatility is expected to continue. Often driven by people's perceptions rather than genuine market facts.

- Q Banks seem to be guite desperate to be more involved in offering financial advice?
- A Have to be qualified to provide advice Institutions, banks and accountants in same situation and new regulations are coming in
- Q Commonwealth Bank recorded an excellent profit, ex-dividend shares dropped by \$5 immediately.
- A Frequently happens after dividend payout lot relates to people's perceptions.
